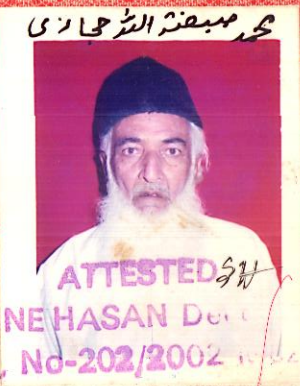

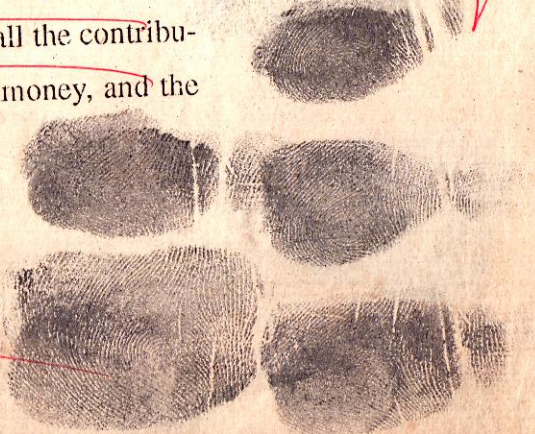

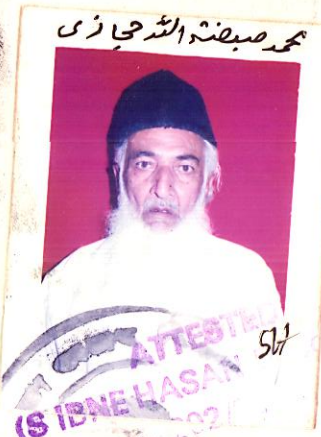

 - v) To establish and run hostels, boarding house, dormitories etc. for students and teachers.
 - vi) To run audio- visual units.
 - vii) To award scholarship for deserving students of technical, medical and professional courses.
 - viii) To establish and manage centres for religious discourses and for imparting moral education and for propagation of Islamic teaching, philosophy culture and way of life among muslims minority and other who likes.
 - ix) To print, published, exhibit and organise films, journals, perodicals, books, Lectures and other audio visual matters for the diffusion of useful knowledge in keeping with the educational, medical charitable, and moral ideas of the society.

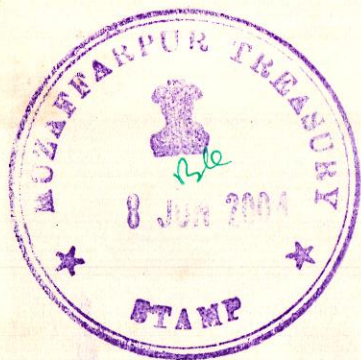

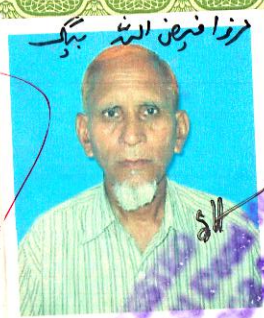

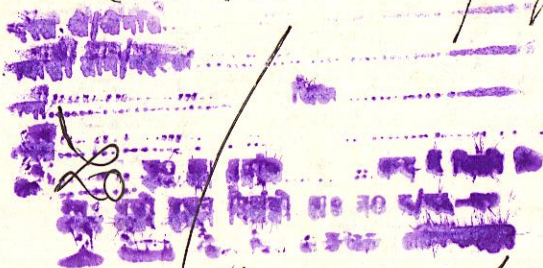
- xi) To collect, classify and circulate statistics and other informations relating to Indian economy for the benefit of all.

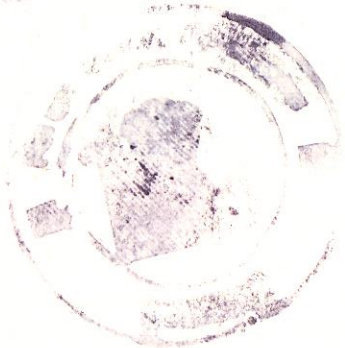

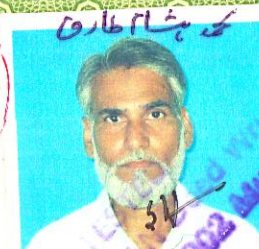

- vi) To open and maintain account or accounts of the trust in a Bank for the purpose of keeping the money of the Trust and to operate the same or to authorise any one or more of them to operate them:
- vii) To hire or to take on lease or purchase, construct or to enter into a development agreement or let-out and sell any land, building and other immovable or movable properties in the name of the Trust.
- viii) To invest, dispose of, transfer and other wise deal with the subject matter of the Trust in such manner as the Trustees deem fit and proper to do in carrying out object of the Trust;

- xii) To invest the funds of the trust not immediately required in deposit with nationalised Banks or with undertaking or in any securities authorised under the Income Tax Act 1961, or other applicable laws in force from time to time.
- xiii) To create any Reserve Fund, sinking Fund Insurance Fund Provident Fund or any other special fund whether for depreciation or repairs, improving, extending or maintaining, any of the properties or rights of the Trust and /or for recoupment of washing assets and/or for benefits of the employees and for any other purpose for which the trust deems it expedient or proper to create or to maintain any such funds or funds;
- xiv) To do all such other lawful acts, deeds or things, either alone or in conjunction with other organisations, as are incidental or conducive to the attainment of any of the above objects;
- xv) To provide for the welfare of employees of the Trust;
- xvi) To make Rules and Regulations for conduct of the affairs of the Trust or institutions run managed and controlled by trust and to add, amend vary or rescind them from time to time;

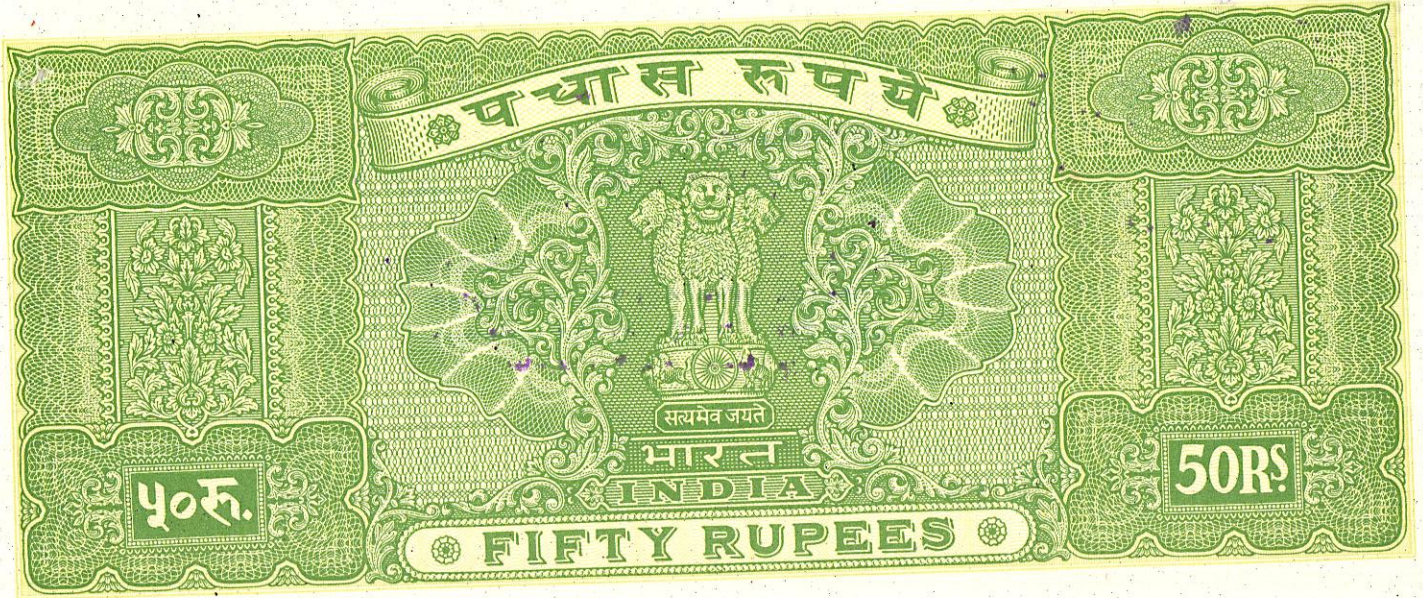

4.0 Board of Trustees :

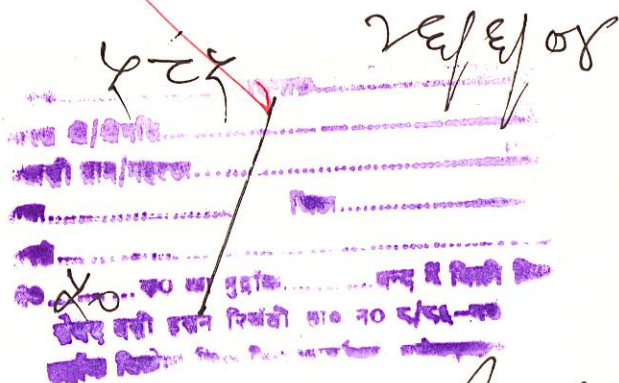
